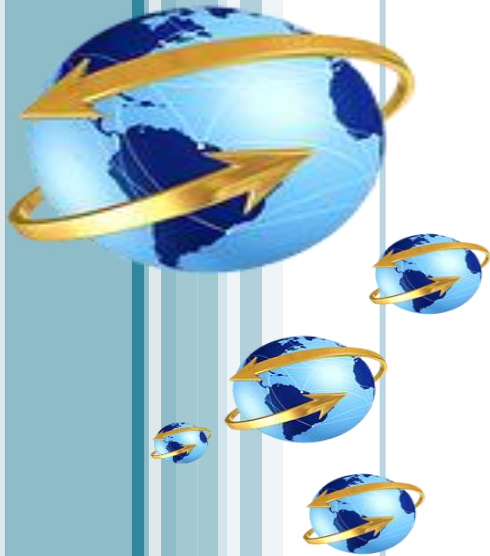

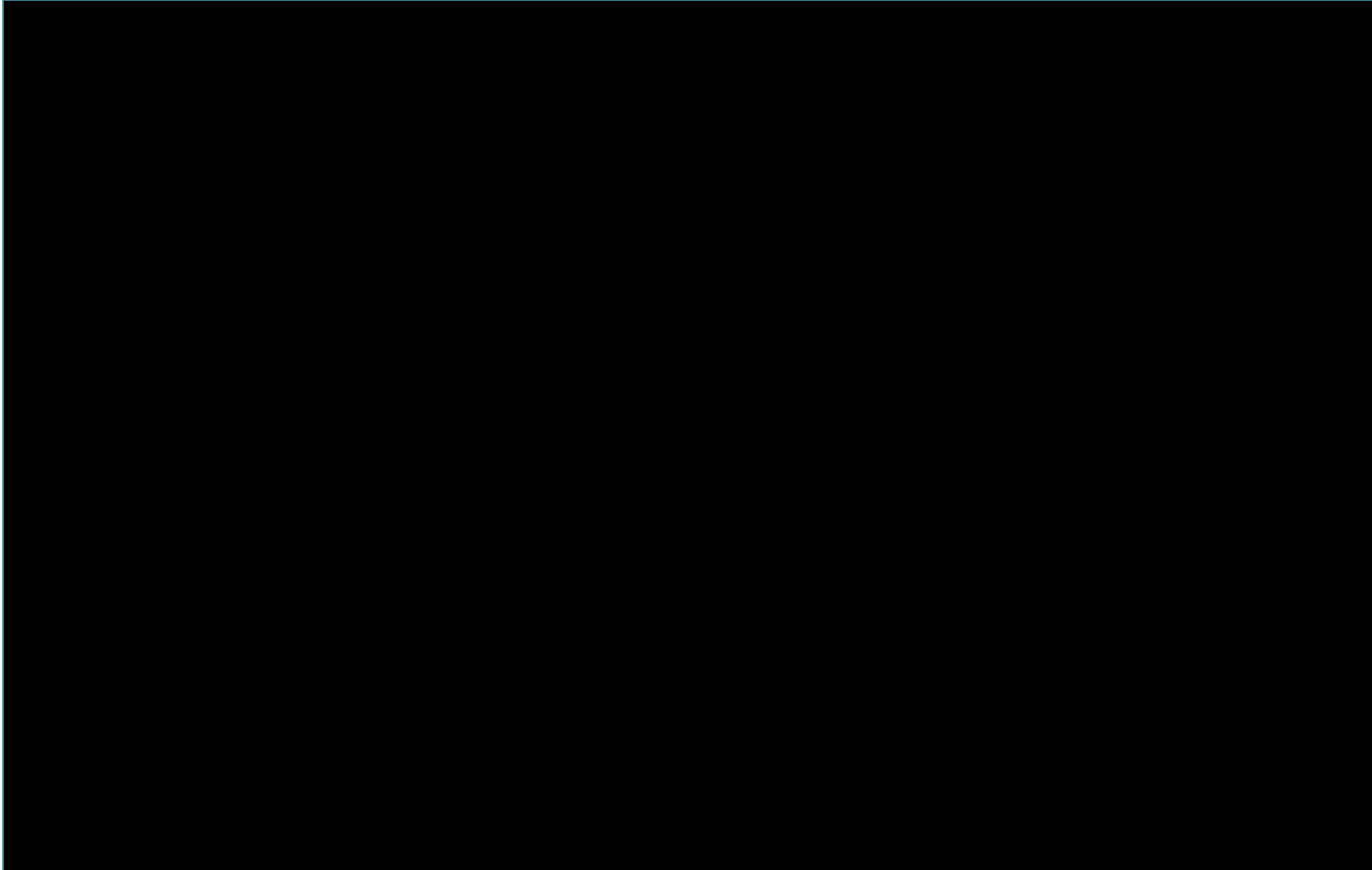

The SDSU [REDACTED] Program anticipates only having 1-2% more than the normally allocated 25% for carryover for the 2015-2016 grant year. This 1-2% of unspent funds is a result of a handful of programmatic items: a larger than expected number of [REDACTED] students performed summer research offsite and were funded by other institutions for that period, yielding an unanticipatedly large amount of unspent student support funds. Additionally, this year travel expenses were lower than expected, as a majority of our students obtained travel awards for conferences such as [REDACTED] that are keystone research events for our program. We anticipate using the remaining carry-over, as we will be working with a full roster of 25 students soon, based on the number of students graduating, the number of applicants we have received, and program interviews conducted thus far.

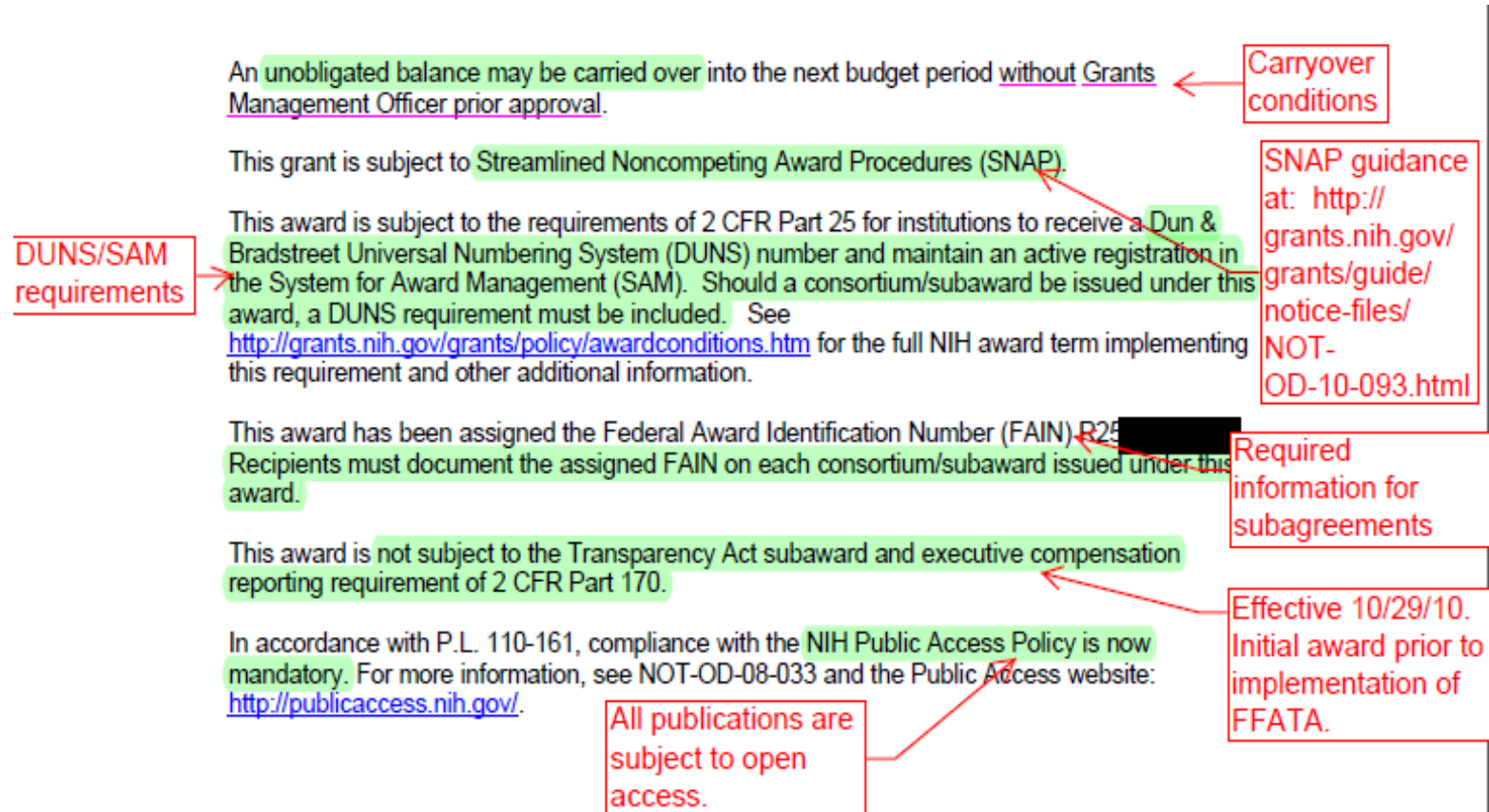
